I. Welcome and Opening Remarks

Mr. Ron Volk, President, welcomed everyone to the Annual Meeting. He thanked special guests in the audience: Cami Roth Szirotnyak, Lucas County Clerk of Courts office; Kim Priestap, Ohio Attorney General's office; and Michele Grimm, Ohio State Representative. Mr. Volk then introduced the Board members.

II. Board Business:

A. Oath of Office:

As required by the Ohio Constitution, Board members took the oath of office, which was administered by Judge Jack Puffenberger of the Lucas County Probate Court. Judge Puffenberger thanked Board members for their service on the Board.

B. Call to Order:

Mr. Volk, President, thanked Judge Puffenberger. He then called the meeting to order at 6:36 p.m. Roll call was conducted and all Board members were present.

C. Consent Agenda:

After roll call, Mr. Volk made a motion to approve the Consent Agenda dated April 28, 2025 as submitted. Seconded by Mr. Axe. Motion carried unanimously.

III. Keynote Speaker: Eric Chase, Cumulus Media

Mr. Nabil Shaheen, Community Outreach and Communications Manager, introduced the keynote speaker, Mr. Eric Chase, a local radio host for Cumulus Media.

Mr. Chase spoke about sharing his story to empower others to help themselves or help others. His joy comes through purpose and purpose, he said, “gets you out of bed every morning. You don’t have to chase it. You can fulfill a personal mission or a mission for others. When you do something for others, it is often far more rewarding. Don’t chase happiness. Find your purpose and wake up with that every day.” His closing remark, “Don’t be the best in the world, be the best for the world.”

Mr. Shaheen thanked Mr. Chase for his presentation.

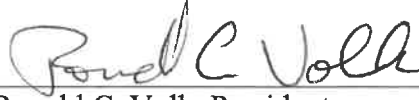
